| 6.1 | BHNCC The lease was for 30 years but BPC would prefer 10 years. This to be proposed to the Chair of cricket club. The CC need to do a PR campaign as they have difficulty recruiting new members. They are applying for grants to get new equipment to enable them to teach new cricketers. Nets need replacing. Proposal for a sign at top of road near to rose triangle advertising the CC. | Noted | |

The plan is to get the landowner to submit a planning application to planning at EHDC. | 6.5 | Friends of Baker Arms FOBA have formally advised EHDC of the intention to submit a bid for the pub. The formal Red Book survey of the pub was completed in December 2023. A bid has been submitted to McMullens and there was a face to face meeting last week with Tom McMullen. He fully supported a pub to remain on the site. The site could be split – the B&B rooms revert to 2 cottages, the car park could interest a developer – pending planning permission. The community just runs the pub. As a volunteer group it may be better to have a smaller area to manage. KC stated that the Rose and Crown in Aston have done similar, a developer bought the site and sold the pub to PC for £165k. KC to send details to OR. McMullens have agreed to share drawings already received from a developer recently. | Noted/KC | |
